

Statistics of 2018 BIS License Authorization

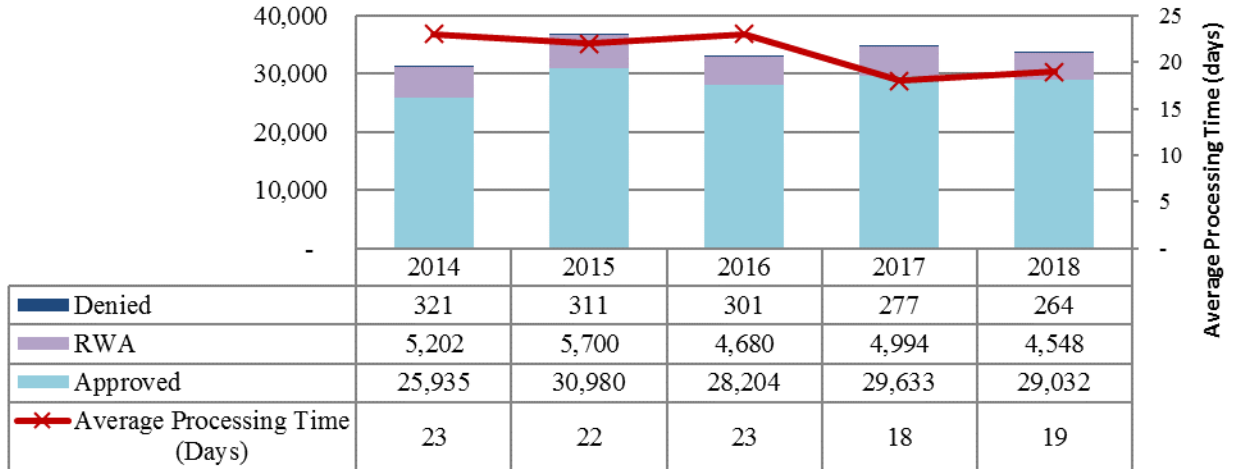
In 2018, BIS reviewed a total of 34,851 license applications. Of these, 33,844 license applications for exports and reexports for tangible items, software and technology, a decrease of 3.0% (1,060 less) from 34,904 in 2017.

- Approved licenses decreased 2.0% (601 less) from 29,633 in 2017 to 29,032 in 2018. The approval rate was 85.8%;
- Denied licenses applications decreased 4.7% (13 less) from 277 in 2017 to 264. The denied rate was 0.8%;
- Return without action (RWA) decreased 8.9% (446 less) from 4,994 in 2017 to 4,548. The RWA rate was 13.4%.

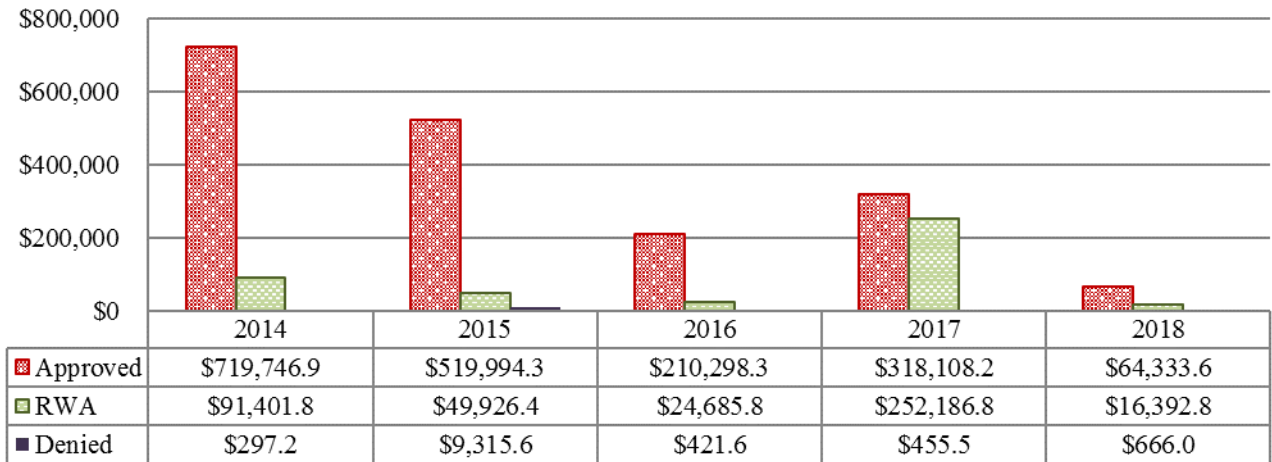
**BIS Licenses for Tangible Items, Software and Technology for the World

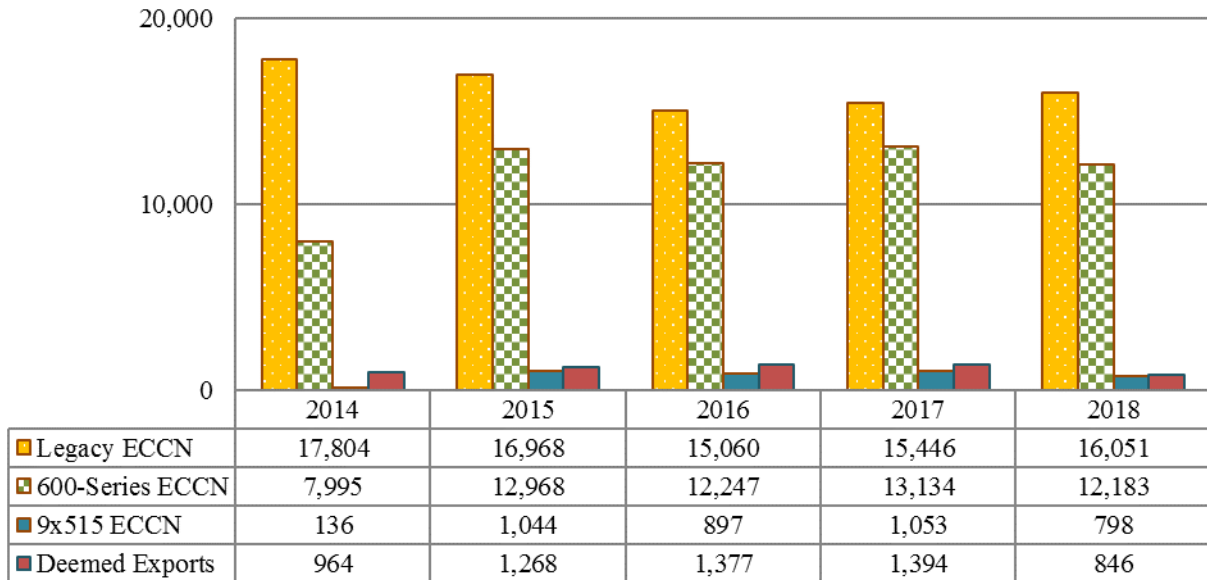

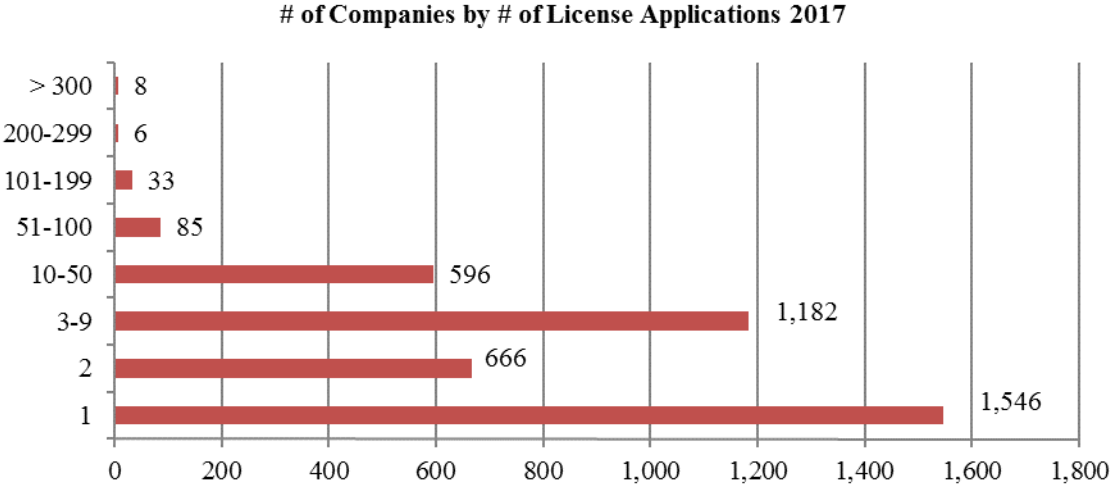

In 2018, 3,102 companies submitted a total of 34,851 license applications, including deemed exports. 1,101 companies applied for only one license, 506 companies applied for two licenses and 937 companies applied for three to nine licenses. Together, 2,544 companies (82.0% of total applicants) applied for one to 9 licenses, accounted for 19.0% of the total applications.
